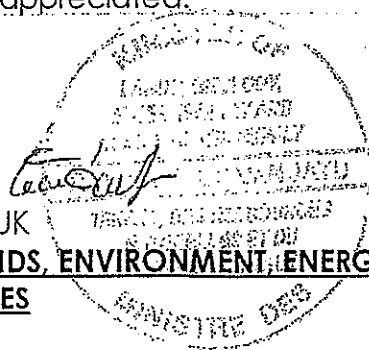

- e) The developer must be informed also that there will be continuous monitoring of development activities by the Department of Environment and Conservation and other appropriate departments during and after completion of the development project to ensure conditions are complied to at all times.
